Due to the small size of the customer base in Adair, Iowa, the project's feasibility depends on reducing upfront and operational costs as much as possible. The City of Adair has determined that the best way to achieve operational costs savings is to partner with an existing provider, Casey Mutual Telephone, that has the knowledge and experience to provide excellent service rather than the City providing those resources. The State of Iowa Broadband Grant Program will help feasibility and sustainability of the project by Iowering the upfront costs of network construction, which will Iower the amount of Iong-term debt the City will need to deploy.

While the City of Adair Fiber Project may still be feasible without State of Iowa support, the grant will greatly improve the chances of the project coming to fruition and the citizens of Adair, Iowa gaining access to fast, affordable, reliable, and ubiquitous fiber-based broadband services for the first time.
