



FUNCTIONAL AREA 2 COMMUNICATION SKILLS

Verbal Defense, Influence, and De-escalation

Provides the skills and strategies to diffuse and deescalate highly charged, emotional, situations; training officers to set the initial tone.

It ties in the themes from Cultural Competency and Race Relations and focuses on the ability to communicate in an open, flexible and unbiased policing approach—working toward a positive outcome.



FUNCTIONAL AREA 3 LIFE SKILLS

Iowa Law Enforcement Emergency Care Provider

Medical Training

Concentrates on the importance of putting physical injuries and medical emergencies first in assessing ill or injured persons, for effective treatment and communication.

Special Needs Population

Focuses on seeing the person first and how to communicate with the individual.

Crisis Intervention Training

Mental Health Training

Held near the end of the Basic Academy, CIT takes all principles learned in technical skills, communication approaches and overall respect and recruits apply strategies to diffusing crisis situations in practical scenarios.

FUNCTIONAL AREA 4 LEGAL TOPICS

Procedural Due Process

Provides an overview to how the criminal justice system in America operates. Recruits are provided skills to recognize the potential for bias in the process and to recognize that laws change to reflect the current societal values.



FUNCTIONAL AREA 5 PATROL PROCEDURES

Gangs

Designed to introduce the criminal gang subculture and address those that currently exist in Iowa communities.

Observation & Perception

Addresses how past experiences can affect the perception of a situation, and how the conditioning of our mind can result in prejudices or bias as we respond to situations.

Terrorism Awareness

Provides past and present terrorist activities and tactics to illuminate potential indicators of terrorism and criminal extremism.



FUNCTIONAL AREA 6 INVESTIGATIONS

Hate Crimes

Provides the legal basis for identifying hate crimes and applying the law in criminal investigations. Emphasizes the effect bias-motivated crimes have on a community.

Human Trafficking

Educates recruits on the laws pertaining to human trafficking and the ability to recognize sex and labor trafficking. Outlines myths and realities on human trafficking.

Sexual Abuse Investigation and Domestic Violence

Provides techniques and methods for investigating sexual abuse and domestic violence calls. And also creates awareness of the differences in victims, tying in investigative approaches from the classes Introduction to Trauma and Trauma Informed Interviewing.



FUNCTIONAL AREA 7 TACTICAL SKILLS

Fire Arms Training Simulator (FATS)

Provides students the opportunity to apply knowledge gained in other classes through simulated events. These events include, but aren't limited to:

- Domestic Violence Calls
- Felony Warrant
- Home invasion
- Active Shooter
- Suicidal Neighbor
- Vehicle Stops
- Hostage Rescue
- Canine Attack
- Prisoner Transport
