

Included as part of the 12 exchanges reflected herein, the communities of the Amana Colonies (Amana, East, Middle, High, South, West, and Homestead), Cosgrove, Ely, Fairfax, Newhall, North Liberty, Norway, Oxford, Solon, Shueyville, Swisher, Tiffin, Watkins, Walford, Western, South Cedar Rapids and parts of Coralville are also served by South Slope.

South Slope provides telecommunications services (regulated and non-regulated) as a local exchange carrier in central Iowa. ILEC provides telecommunication exchange, local access service, long distance, Internet, video and telecommunications equipment sales.

South Slope Cooperative Telephone Company (CLEC/EBA) overbuilt the exchanges of Solon, Oxford and Tiffin. CLEC/EBA also provides services in the extended boundary areas of Cedar Rapids and Coralville. CLEC/EBA provides telecommunication exchange, local access service, long distance, data, video, and telecommunications equipment sales. South Slope Cooperative Telephone Company (ILEC) provides all management, accounting, customer service, and plant personnel to CLEC/EBA.

South Slope Cooperative Telephone Company (ACQ) is another division of South Slope Cooperative Telephone Company. The exchange of Amana was acquired by South Slope Cooperative Telephone Company on July 1, 2006. Per an order issued by NECA, South Slope Cooperative Telephone Company is required to keep acquired assets, revenues and expenses separate from South Slope Cooperative Telephone Company (ILEC) operations. ACQ provides telecommunications exchange, local access service, long distance, data, video and telecommunications equipment sales.
